- If the Applicant Society/ College has not fully rectified the deficiencies within the stipulated time as reported by the University prior to the issuance of this order, if any.

Further, the deficiencies, if any reported in this Provisional Affiliation Order, are only based on the available records and information submitted by the Applicant Society/College and thus, these deficiencies may not be considered exhaustive and the final details of the deficiencies or violation/non-compliance of the affiliation norms will be reported by the University after completing a detailed inspection in the matter.

- 9 The management should not change the Programs / Combinations, intake and media etc. sanctioned in these proceedings, failing which, such action will be construed as tampering of records for which the University will initiate necessary legal action against the Management.
- 10 The Management shall neither make any excess admissions without approval of the concerned competent authority and the university nor make admissions without affiliation of the University
