Policy Document on Declaration of Results

Grading Scales: A standardized CGPA and SGPA grading scale is used consistently throughout the college, defining grade ranges and corresponding grade points. This scale is communicated to students at the beginning of the academic year.

Continuous Internal Assessment (CIA): Where applicable, Continuous Internal Assessment forms an integral part of the assessment process to evaluate a student's performance throughout the course.

Result Declaration Process

Timeliness: ANR College ensures that results are quickly announced after the completion of assessments and examinations, in accordance with specified timeframes. Confidentiality: The findings of students are regarded as confidential data. Access to this data is restricted to authorised individuals only, and strict data protection measures are used.

Quality Assurance: The College maintains a rigorous quality control mechanism to ensure the accuracy of result calculation and data entry.

Result Publication

Results are disseminated to students via the official college website, https://anrcollegeexams.com. This website offers a secure and authorised means of accessing result information.

Result Declaration Process

Students possess the entitlement to solicit a reassessment of their outcomes if they hold the belief that a mistake has occurred or if they harbour issues regarding the evaluation procedure. An organised and systematic review process is established.

Students have the option to utilise an appeal process if they desire to contest their findings. This procedure is characterised by transparency and impartiality, guaranteeing an equitable settlement of conflicts.

Records and Documentation

ANR College securely and systematically preserves records of all assessment data, which includes exam papers, grading rubrics, and student results. The institution's policy mandates that these records be kept for duration of five years from the date of enrolment.
